## **CYBERWAR is Imminent & Will Affect Ordinary Americans, Claims CEO of Company That ‘Discovered’ SolarWinds Hack**

## ICAN LEGAL UPDATES



### **Michigan Department of Health is Second Public Health Agency to Comply with ICAN's Legal Demand That They Remove "Misinformation" Regarding the Covid-19 Vaccines From Their Social Media Posts**

ICAN achieved another victory in its ongoing campaign to ensure the government does not spread false information about vaccines. Michigan’s Department of Health and Human Services posted a graphic and accompanying message on its public

Facebook page. The text falsely stated that “on the journey to FDA approval, each COVID-19 vaccine had to pass through the same thresholds of research & testing as every other vaccine.” It went on to include additional, incorrect information: “all three of the approved COVID-19 vaccines were proven to be safe and 100% effective in preventing hospitalization and death in the clinical trials.” ICAN, through its attorneys, wrote to the Director and to the Chief Deputy of Health of MDHHS demanding they remove the false graphics and messaging regarding COVID-19 vaccines. They quickly complied within 48 hours and removed the relevant false messaging.

Soon after ICAN successfully challenged the New York State Department of Health’s false social media messaging regarding COVID-19 vaccines, on March 8, 2021, ICAN’s attorneys sent a letter to Michigan Department of Health and Human Services (MDHHS) informing them that they were violating federal law. MDHHS’ posted the following graphic and messaging on Facebook (see first image).

This social media messaging – intended for the public – made numerous false claims. First, it claims that the FDA “approved” a COVID-19 vaccine. This is categorically false. There is no COVID-19 vaccine that has been “approved” by the FDA. The only three COVID-19 vaccines currently in use are authorized by the FDA pursuant to an emergency use authorization (“EUA”). In fact, the FDA authorization letters for both COVID-19 vaccines expressly provide that the vaccines are each “an investigational vaccine not licensed for any indication” and require that “[a]ll promotional material relating to the COVID-19 Vaccine clearly and conspicuously ... state that this product has not been approved or licensed by the FDA.”

In addition, the three COVID-19 vaccines are still undergoing clinical trials, hence they were also spreading misinformation when they claimed that these EUA authorized products “had to pass through the same thresholds of research & testing as every other vaccine...” ICAN had to point out to a health agency that the FactSheets for Recipients for each of these vaccines unambiguously state that the vaccines “ha[ve] not undergone the same type of review as an FDA-approved or cleared product.”

Further, the Facebook post claimed that all three vaccines’ clinical trials have proven to be “100% effective in preventing hospitalization and death.” This is also categorically false. The FDA’s review memorandum on each of the vaccines lists as

one of the “Unknown Benefits/Data Gaps” “effectiveness against mortality.” The FDA makes clear: “A larger number of individuals at high risk of COVID-19 and higher attack rates would be needed to confirm efficacy of the vaccine against mortality.” Additionally, the FDA’s Review Memorandum for Moderna’s vaccine states: “There were no deaths due to COVID-19 at the time of the interim analysis to enable an assessment of vaccine efficacy against death due to COVID-19.”

It is also false to claim that these vaccines have been proven to prevent 100% of hospitalizations. In the Moderna trial, one participant in the mRNA-1273 group, a participant >65 years of age who had risk factors for severe COVID-19, was hospitalized due to oxygen saturation of 88% on room air 2 months after receiving the second dose of vaccine.” In the Janssen trial, in a post hoc analysis of all COVID-19 related hospitalizations starting 14 days after vaccination, including non-centrally confirmed cases, there were 2 cases in the vaccine group. Likewise, the Pfizer trial reported two serious cases of suspected but unconfirmed COVID-19, both in the vaccine group, where both vaccine recipients were hospitalized.

Michigan’s Department of Health needed to be fact checked. We are pleased to tell you that, after being notified that failure to remove the inaccurate graphic and its false messaging would result in a lawsuit, MDHHS responded and removed any reference to “approved” vaccines and to the completely false claim that the vaccines are 100% effective in reducing hospitalizations and death.” This is another victory that should serve to remind MDHHS, and every other public health department, that someone is watching. And if the FDA and our federal health authorities will not ensure that the public is receiving true and accurate information, ICAN will. ICAN’s message should be heard loud and clear: you may not spread “misinformation” about vaccines.

To that end, the revised post, while clear of two false assertions, is still misleading (see second image).

ICAN’s attorneys sent another letter to MDHHS explaining that it is still not accurate to state that the COVID-19 vaccines “had to pass the same thresholds of research & testing as every other vaccine.” Every other vaccine that MDHSS is referencing has been licensed and approved. In stating that the COVID-19 vaccines have undergone the same review, MDHHS is not “clearly and conspicuously” stating

that this product has not been approved or licensed by the FDA. Quite the opposite is true.

Additionally, the post now states that the vaccines were “proven to be safe and effective.” In fact, the FDA has stated this is not the case: “Based on the safety and effectiveness data, and review of manufacturing information regarding product quality and consistency, it is reasonable to believe that Moderna COVID'19 Vaccine may be effective. Additionally, it is reasonable to conclude, based on the totality of the scientific evidence available, that the known and potential benefits of Moderna COVID'19 Vaccine outweigh the known and potential risks of the vaccine, for the prevention of COVID-19 in individuals 18 years of age and older.” It is highly misleading for a health agency to state in unambiguous terms what the FDA has not yet proven or stated itself. We will keep you apprised of any response to the latest letter.

### **ICAN Informs New CDC Director of Significant Concerns Regarding VAERS Using Anaphylaxis Post-Covid-19 Vaccination as a Pointed Example**

ICAN, through its attorneys, has once again written to Dr. Rochelle Walensky, the new Director of the CDC, this time to demand an answer as to why the CDC's reporting of anaphylaxis following COVID-19 vaccination is not in line with a clinical study conducted which shows much higher rates following these vaccinations. The CDC tells the public that “Anaphylaxis after COVID-19 vaccination is rare and occurred in approximately 2 to 5 people per million vaccinated in the United States based on events reported to VAERS.” However, ICAN reviewed a recent study at Mass General Brigham that assessed anaphylaxis in a clinical setting after the administration of COVID-19 vaccines. This study, in stark contrast to the CDC's claim, found “severe reactions consistent with anaphylaxis occurred at a rate of 2.47 per 10,000 vaccinations.” This is equivalent to 50 times to 120 times more cases than what VAERS and the CDC are reporting!

In a letter to Dr. Walensky, ICAN explained that this alarming underreporting of anaphylaxis by the CDC and VAERS is particularly troubling because it is mandatory for medical providers to report anaphylaxis after any COVID-19 vaccine to VAERS.

In addition, the CDC reports that most of these reactions occur within 30 minutes of vaccination. The study reported that the mean time to reaction is 17 minutes post-vaccination. This means that vaccine administrators, then, should be aware of a majority, if not all, of these cases as vaccine recipients are supposed to be observed for 15 to 30-minute periods following vaccination at all vaccination sites.

Additionally, and specifically with regard to COVID-19 vaccines, there has actually been a push by health authorities to inform medical providers that they need to report anaphylaxis to VAERS. Despite this, the rate of reporting still appears to be only around 0.8 to 2 percent of all cases of anaphylaxis. (This is close to the Harvard Pilgrim study which found that approximately 1% of adverse events are reported to VAERS).

ICAN explained to Dr. Walensky that this raises serious concerns regarding (i) under-reporting of other serious adverse events following COVID-19 vaccination, and (2) adverse events following other vaccines for which there has not been the same push to report adverse events. The anaphylaxis study highlights the urgency of the ongoing, well-known problem with adverse event reporting post-vaccination which ICAN has been pointing out for years.

Unless and until this is addressed, underreporting to VAERS, a passive signal detection system, will continue to blind health agencies, medical professionals, and patients from what is really occurring in the clinic and will render true informed consent impossible.

ICAN continues to ask the hard questions of Dr. Walensky and others. ICAN will closely review any response from Dr. Walensky and will continue to push for improved transparency regarding vaccines and their development, clinical trials, and safety surveillance.
